Passenger Information

CONDITIONS OF CARRIAGE Your ticket is subject to the Conditions of Contract printed inside the ticket and to Community Express's Conditions of Carriage of Passengers and Baggage, copies of which can be obtained at any Community Express office. A brief summary of information useful to passengers is given below, for full details apply to any Community Express office or appointed travel agent.

CHILDREN AND INFANTS On domestic flights, an infant under 2 years, accompanied by an adult and not occupying a seat, is carried free; on international flights 10% of the adult fare is applicable. Children 2 years or more, but under 12 years are carried at 50% of the adult fare on all flights, unless specified otherwise.

UNACCOMPANIED CHILDREN Children between the ages of 6 and 12 years inclusive may travel unaccompanied by prior arrangement.

BAGGAGE ALLOWANCE There is no free allowance for infants. For all other passengers, the free baggage allowance is: Domestic: 15 Kg per person. Excess baggage will be charged at the appropriate rate. Baggage must be labelled with passenger's name and address both inside and out. Community Express assumes no liability for damage to fragile, valuable or perishable items in checked baggage.

HAND BAGGAGE The MAXIMUM acceptable dimensions for hand baggage is 45cm x 35cm x 15cm and the MAXIMUM weight is 5 kilos. Hand baggage is restricted to one piece per passenger. On certain turbo-prop aircraft only very limited space is available on board for hand baggage, and your co-operation with ground staff and cabin crew is very much appreciated.

PROHIBITED ARTICLES Government regulations prohibit the carriage of certain articles such as, explosives, compressed gases, radioactive/magnetic materials, biological materials etc. Instruments or articles containing mercury must be packed as to avoid spillage. If in doubt as to whether other articles may be carried, please contact any Community Express office or appointed travel agent.

FLIGHTS TO/FROM BELFAST CITY All baggage is required to be searched by security personnel. Proof of identity should be carried. Strictly one piece of cabin baggage allowed.

CHECK-IN-TIMES The check-in time shown is the latest time by which check-in formalities should have been completed. Community Express reserves the right to cancel and offer for resale any reservations not taken up at this time. No refund will be due, and departure cannot be delayed for passengers checking-in after this time.

SMOKING In the interests of safety and comfort, Community Express Airlines operate a no smoking policy and would be grateful for passengers' co-operation throughout the aircraft at all times.

IMPORTANT The details contained within this timetable are based on the latest information that is available at the time of going to press and are subject to alterations by the Company, without notice. All times shown in this timetable are local and 24 hour clock timings are used throughout.

AIR PASSENGER DUTY A new air passenger duty has been introduced by the Government on all flights both within and from the U.K. The amount charged is dependent upon the journey itinerary planned with a minimum charge of £5.00 duty per adult. Infants not occupying seats and passengers in transit from International destinations are exempt from this charge.
